Sir/Madam,

As per the above-quoted letter, on the basis of your request and the self-declaration given by you, I hereby issue and send provisional mandate to KPS World School, Village Daun, and District SAS Nagar from Class I to Class VIII up to 31.03.2022 on the following conditions.

Conditions:

1. It will be the personal responsibility of the school management to submit the building safety certificate and fire safety certificate of the school to this office as per the deadline. In case of negligence, the process of cancellation of the recognition of your school will be initiated.
2. The approval of accreditation is not renewable and in no case is it applicable to accreditation/affiliation beyond class VIII.
3. The above recognition is based on the self-declaration given by you. If any of the information entered in the self-declaration is found to be incorrect or false, then the process of cancelling this recognition will be initiated.
4. The palace is being run by a society registered under "Society Registration act 1860 (Act No. 21, 1960) or by a trust established under any law in force from time to time.
5. Renewal of the society's registration, if necessary, will be ensured.

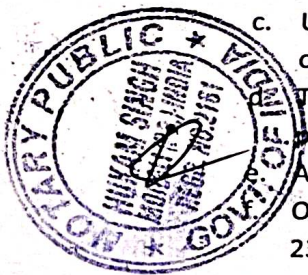

6. The school is not being run for the personal benefit of any individual, group or groups of individuals or anyone else.
 7. The school accounts will be audited and certified by a Chartered Accountant and proper statements of accounts will be prepared as per the rules.
 8. The school shall admit 25% of the total strength of the class in class I to children belonging to the weaker sections and disadvantaged groups of the neighbourhood and shall provide free and compulsory education till its completion. If the school provides pre-primary education, the same conditions shall apply.
 9. For the children referred to in paragraph 7, the school will be reimbursed for the expenses as per provision 2 of section 12 of the Act. The school will have to maintain a separate bank account to receive this reimbursement.
 10. The school will not charge any capitation fee and will not subject the child or his/her parents or guardians to any selection process.
 11. The school shall not refuse admission to any child for the following reasons:-
 - a) Lack of proof of age of a child;
 - b) Any child seeking admission within or after the extended period; or
 - c) Religion, caste, race or place of birth or any of these reasons.
 12. The school will ensure that:-
 - a. No child admitted will be held back in class or expelled from school before completing primary education in the school.
 - b. No child shall be subjected to physical punishment or mental harassment.
 - c. Until the completion of the religious education, the true one will not need to pass the test of the any board examination.
- This certificate will be provided to every person who has completed primary education as per rule 21.
- According to this act handicapped/special child/ will get admission.
- Only teachers fulfilling the minimum educational qualifications as per sub-rule (1) of section 23 of the Act shall be appointed.
- g. Teachers shall not engage themselves in any private teaching activity.

13) The school will adopt the curriculum based on the subjects prescribed by the appropriate authority.

14) The school shall comply with the conditions and standards specified under Section 19 of the Act.

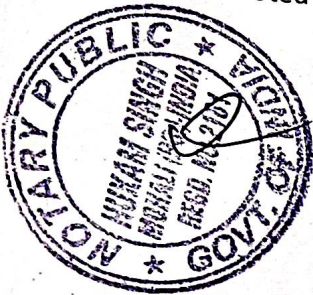


- 15) No unaccredited classes will be conducted inside or outside the school building under this name of the school.
