2. Teaching Punjabi in your school will be compulsory upto Tenth standard and CBSE New Delhi will make efforts to conduct Punjabi exam in such schools and it is also said that in case of not doing so, the no objection certificate will be withdrawn immediately.
3. RTE by School Management, Department of Education Punjab Govt. Act, 2009 literature issued notifications and rules of RTE Act 2009 made for the state of Punjab will be strictly followed.

4. Management of the school after getting acquiescence of CBSE New Delhi Two teaching staff and non-teaching staff will be committed to pay salary and five

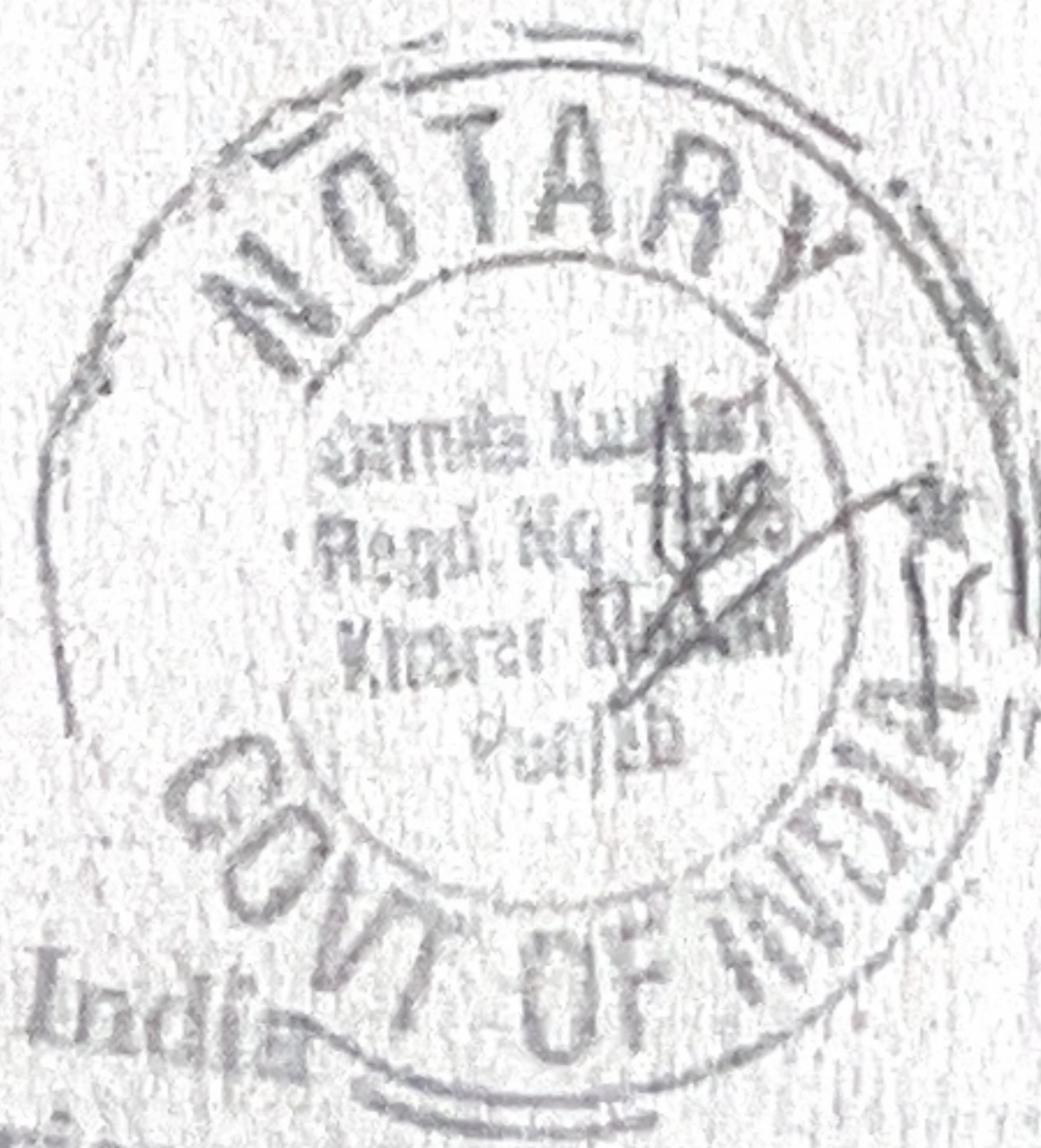
